## Information Sheet on the Privacy Policy

The GGC informs, supports, and advises you on all matters relating to dance sport. In doing so, your personal wishes and preferences shall be considered. All competition data that the GGC processes and uses are subject to the German Federal Data Protection Act and the European General Data Protection Regulation (GDPR).

The use of data is permitted if the German Federal Data Protection Act or another legal provision allows it, or if you have given your consent. For comprehensive information, advice, and support, your explicit consent is therefore required.

## Validity of the Privacy Policy

Your consent remains valid beyond the termination of your membership in the GGC but expires after the statutory retention periods have elapsed or if you withdraw your consent, which is possible at any time.

## Examples of Data Collection, Processing and Use

The GGC collects and stores data that are required for membership in a dance sport club. This initially includes your personal details (name, address, date of birth, email address, telephone number, bank details and/or comparable data). In the course of competition activities, this also includes all competition-related data, such as ID number and results. The GGC may publish competition data, competition results, and photos on the internet and in the press. The primary responsibility for the lawful processing of your data in accordance with data protection regulations lies with the GGC.

You are aware that, despite all measures taken to ensure data protection, data published on the internet or in the press may also be accessed in countries that do not have data protection standards comparable to those of the Federal Republic of Germany. Furthermore, it cannot be guaranteed that such data will remain confidential, that their content will remain accurate, or that the data will not be altered.

## Right of access

Under the GDPR, you have the right to obtain information about the data stored about you by the GGC.

## Right of Withdrawal / Request for Deletion

Under the GDPR, you have the right to have your data stored by GGC Bremen deleted.
